Don't let your fleet be detained

SOLAS Chapter II-2 requires every SOLAS-regulated ship to have the right fire radio equipment in place by 1st July 2018. Any non-complying vessels may be detained, with the risk of significant costs and delays to their shipping schedule.

Play it safe

There are factors which can inevitably delay the delivery and set-up of your firefighting equipment, such as fleet logistics, availability and shipping issues. As such, leaving your choice of radio too close to the SOLAS deadline can put your fleet and business at risk.

- Each Fire Party on board must have 2 dedicated UHF handheld radios
- All firefighting radios must meet SOLAS regulatory standards
- Failing this can result in ports detaining contravening vessels
- Port fees can exceed \$20,000 - \$30,000 per day
- Cost of delays to shipping schedules can exceed \$100,000 per day
- Fires can occur anytime, so you need the right equipment on board right now

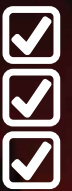
